Germany

The country follows an 8-step process provided by the World Health Organization. This is as follows:

- 1. Appointment and referral: This involves patients referring to the institutions that provide wheelchairs. In Germany, patients are referred through healthcare institutions.
- Assessment: This involves evaluating the patient's environment, condition, and lifestyle. In Germany, trained personnel carry out this process.
- Prescription: This involves the selection of the right wheelchair for the patient. In Germany, wheelchair service personnel play a significant role in prescribing the right wheelchair.

- Ordering and Funding: This involves obtaining finances from various sources and ordering the wheelchair. In Germany, non-governmental organizations are the primary sources of funds.

- 6. Fitting: This involves the final assembly and fitting. Trained personnel carry out this job.
- User Training: The patient is given specialized training on using the wheelchair. Healthcare institutions in Germany are responsible for training the users.
- Repairs, Maintenance, and Follow-Up: This involves providing repair and maintenance services to the wheelchairs and following up on the users. The wheelchair service providers offer these services.

The United States

- 1. Appointment and referral: In the U.S., different institutions providing healthcare services are responsible for referring patients.
- 2. Assessment: Trained personnel and technicians carry out this process.
- 3. Prescription: Health institutions prescribe the right wheelchairs for patients.
- Ordering and Funding: Non-governmental organizations and insurance funds such as Medicare and Medicaid are the primary sources of funds.
- 5. Preparation of the product: Trained personnel and technicians prepare the wheelchairs.
- 6. Fitting: In the U.S. trained personnel carry out this job.
- 7. User Training: Health care personnel are responsible for training the patients.
- Repairs, Maintenance, and Follow-Up: Wheelchair service providers and health institutions offer these services.

The U.K.

- 1. Appointment and referral: In the U.K., healthcare providers appoint and refer the patients.
- 2. Assessment: Trained personnel including healthcare providers execute this task.
- Prescription: The healthcare and other trained personnel recommend the right wheelchairs to patients.
- 4. Ordering and Funding: Non-governmental organizations and the NHS are the primary sources of funds.
- 5. Preparation of the product: Trained personnel and technicians prepare the wheelchairs.
- 6. Fitting: The service providers are responsible for fitting the wheelchairs.
- User Training: Health care personnel and technicians are responsible for training the patients.
- 8. Repairs, Maintenance, and Follow-Up: Wheelchair service providers and health institutions provide these services.

Conclusion

According to the above information, the process differs slightly depending on countries. Most nations use the 8-step process recommended by the WHO. However, each country may have different ways of executing the steps in the process depending on the factors in the country.
